RECORD OF DISCUSSION

The 2023 meeting of the Gulf Groundfish Advisory Committee was held on March 15, 2023 at the Crown Plaza hotel in Moncton NB; a virtual option via the Zoom platform was also offered to participants who were unable to attend in person. Participants included representatives from the groundfish industry, Indigenous groups, provincial governments (New Brunswick, Nova Scotia, Prince Edward Island, Newfoundland and Labrador and Quebec), as well as staff from Fisheries and Oceans Canada (DFO). A GGAC meeting was held this year, primarily to share the results of new science stock assessment and abundance indices updates, and to solicit members' views on TAC levels and other management measures.

The chair (Mireille Chiasson) welcomed participants, provided guidelines on the use of the Zoom platform, and conducted a roll call.

Before moving on with the agenda, Jason Spingle of the FFAW mentioned to the group that Robert Courtney, a member of the GGAC, has passed since the last meeting and acknowledged Mr. Courtney as a strong advocate for local fishing. Laura Ramsay also shared some words of acknowledgment for the work that was done by Michael MacDonald, he was a member of PEIFA who passed away recently.

Update on rebuilding plans

Presented by Daniel Lapierre (DFO Gulf region)

Daniel Lapierre noted the Department is making good progress in developing four rebuilding plans for groundfish in the southern Gulf of St. Lawrence (4T winter flounder, 4T American plaice, 4T,Vn Atlantic cod and 4T white hake). The objective is to have the plans completed by the end of fiscal year 2023. A final draft version will be shared with members of the GGAC in order to obtain feedback from the group.

Questions and Comments:

- Associations shared that it is important to continue the science being done on all species. There is a different dynamic between stocks and we should not only be focusing on one in particular. (Ex. Predation)

Action Items:

Associations are asking to have a meeting once the first draft of the rebuilding plans has been completed.

Other items

The Chair noted that the information on: changes to the NARW measures, the US MMPA, SARP, the Ghost gear Fund, Licencing Policy and Electronic Logbooks (ELOGS) was shared with the group prior to the meeting.

The Chair thanked all the participants, those who made presentations and wished everyone a great fishing season. The Chair concluded the 2023 meeting of the Gulf Groundfish Advisory Committee.
