PROGRAM OBJECTIVES

The Department of Fisheries and Aquaculture promotes Nova Scotia as Canada's premier fish and seafood province. This program seeks to provide an employment connection between the seafood sector employers and students by encouraging youth employment in the seafood industries that will help to promote the sector as a viable and interesting employment opportunity for future generations. The Fisheries and Aquaculture Student Bursary program aims to address:

- the labour gap for aquaculture, seafood buying, harvesting and seafood processing facilities in Nova Scotia; and
- introduce aquaculture and seafood sector as viable career options.

This program can help you achieve success when you choose to develop the knowledge and skills needed to work in this exciting field.

ELIGIBILITY

Student:

- Canadian citizen or Permanent Resident status;
- a permanent resident of Nova Scotia;
- enrolled in an accredited post-secondary institution in September (of the program year); and
- employed by a licensed Nova Scotia aquaculture operator, seafood buyer, seafood processor or DFO-licensed commercial fishing enterprise guaranteeing a minimum work term of 250 to 500 hours between April 1st to the end of the December.

Fisheries and Aquaculture Student Bursary recipients are well-rounded individuals who have an interest in the aquaculture and seafood industries and who have obtained employment with a licensed Nova Scotia aquaculture operator, seafood buyer, seafood processor or DFO-licensed commercial fishing enterprise gaining hands on experience in everyday operations.

FINANCIAL ASSISTANCE

Maximum financial assistance through this program is \$1,500 per program year, which is in addition to the wages paid by the employer. A student enrolled in an accredited post-secondary institution, who has been employed by a licensed Nova Scotia aquaculture operator, seafood buyer, harvester or seafood processor for:

- a minimum of 250 hours can receive a \$750 bursary; or
- a minimum of 500 hours can receive a \$1,500 bursary.

Students may accumulate hours over multiple years as far back as April 1, 2020 as follows:

- hours earned during the work term* of each post-secondary school year
- hours earned during the work term* of grade 12 school year
- hours earned during the work term* of grade 11 school year

work term = April 1st to December 31st

Note: Hours claimed in previous years are not eligible for funding.



REQUIREMENTS

- Students must retain and submit their Record of Employment(s) (ROE) with an application once accepted into an accredited post-secondary educational institution. Applicants may be required to supply a copy of their T-4 for audit purposes.
- The application must be signed by a licensed Nova Scotia aquaculture operator, seafood buyer, harvester or seafood processor.
- The application must be signed by a parent or legal guardian if the applicant is under the age of 19.

Note 1: If approved, the Award will be issued to the Accredited Post-Secondary Educational Institution in which the applicant is enrolled.

Note 2: Students who are employed by their family operation are eligible to apply.

Note 3: Funding for the program is limited and the final decision to support will be determined by PBRM.

APPLICATION PROCESS

To apply for the Fisheries and Aquaculture Student Bursary Program, complete and submit the Application including:

- 1. proof of enrollment in school (Student ID # must be supplied); and
- ROE(s) from a licensed Nova Scotia aquaculture operator, seafood buyer, seafood processor, seafood harvester or DFO-licensed commercial fishing enterprise.

APPROVAL PROCESS

- 1. Applications are assessed based on the information and supporting documentation provided. If an application requires further assessment or information, PBRM will follow up with the applicant.
- 2. If approved, applicants will receive confirmation that identifies the funding assistance granted.



AUTHORITY

The Department shall have the authority to deny an application if there is evidence of misrepresentation of pertinent information, or if the Department believes that an application does not conform to the spirit of the program.

EVALUATION AND AUDIT

Review and evaluation of bursaries may be carried out by officials of the Nova Scotia Department of Fisheries and Aquaculture (NSDFA) or other parties chosen by the NSDFA for the purpose of audit, analysis, evaluation, program development and determining assistance. This review and evaluation process may be conducted prior to bursary approval, during work or upon work term completion. Applicants may be asked to complete an evaluation survey statement related to their final claim.

CONFIDENTIALITY

Applicants consent to the release of their name and the amount of support received under the program. This specific information is deemed to be public information, to be actively disseminated by the Nova Scotia Department of Fisheries and Aquaculture (NSDFA). NSDFA may provide any information from an applicant to another public body or a law-enforcement agency in Canada to assist in an investigation, undertaken with a view to a law-enforcement proceeding or from which a law-enforcement proceeding is likely to result. Any other information provided, unless disclosed in the manner and for the purposes stated above, will be subject to the confidentiality and disclosure provisions to the Freedom of Information and Protection of Privacy (FOIPOP) Act.
